



**TVOKids Wild Kratts Contest  
Rules & Regulations (“Contest Rules”)**

**Contest Rules:**

Commencing Monday, March 13, 2017 at approximately 3:30 pm (ET) and ending on April 30, 2017 at 11:59 pm (ET) (the “Contest Period”) entrants may enter the TVO Wild Kratts Contest (the “Contest”) online at [www.tvokids.com](http://www.tvokids.com) or by mail. No purchase necessary.

**1.0 How to Enter:**

1.1 There are 2 ways to enter the Contest during the Contest Period. Participants may enter the Contest in any one of the following ways:

1.1.1. Visit [www.tvokids.com](http://www.tvokids.com) during the Contest Period and complete the online entry form by filling in your name, your age, your city and your phone number so we can contact you if you win.

1.1.2 If you do not have access to the internet but would like to participate, you can enter the contest by mailing us your name, age, city, phone number and your drawing of your creature power suit to:

1.2 At the end of the Contest Period, all valid entries that have been received will be entered into a random draw for a chance to win one (1) of four (4) Family Prize Packs to a Live Wild Kratts Stage Show (“Grand Prize”).

**2.0 Eligibility:**

To qualify, all entries must be received on or before 11:59 pm (ET) on Sunday, April 30, 2017.

CONTEST CLOSING: The Contest closes at 11:59 pm (ET) on Sunday, April 30, 2017.

Only valid entries will be eligible for the Prize.

The Contest is open to children (i.e. under the age of 16 years of age) who are residents of Ontario, except the Contest is closed to children of employees, volunteers, representatives or agents of TVO and prize partners. Where the participant is the age of 13 and under, they must have the consent of his/her parent or legal guardian to submit their personal information in order to enter the Contest. In the absence of such parental or legal guardian consent, the entrant will not be able to enter the Contest.

Each Entrant, or their parent/guardian if under age 13, who is chosen as a winner in this Contest must sign a declaration of compliance with the Contest Rules and a release in order to receive the prize components.

### **3.0 Prize Description and Prize Condition:**

There are four (4) Grand Prizes to be won by way of a random draw in this Contest. TVO will randomly select four entries at the end of the Contest Period.

There are twenty-four (24) Secondary Prizes to be won by way of a random draw. The Grand Prizes and the Secondary Prizes shall be collectively referred to in these Contest Rules as "Prize" or "Prizes".

#### **Prize Description:**

The Grand Prize consists of four (4) Family Prize Packs to a Live Wild Kratts Stage Show. Total approximate retail value of each Grand Prize is five hundred dollars CAD (\$500.00)

The winner of the Grand Prize is responsible for all other expenses associated with the Grand Prize.

#### **Secondary Prizes:**

There are a total of twenty-four (24) Secondary Prizes available to be won during the Contest Period, each consisting of Wild Kratts and TVOKids merchandise. Total approximate retail value of each Secondary Prize is twenty dollars CAD (\$20.00).

A total of four (4) Grand Prizes will be awarded in this Contest. In the event that the selected entrants cannot be contacted by phone within five (5) days of being selected or does not otherwise comply with these Contest Rules, the prize will be forfeited and awarded to an alternate entry.

The Grand Prize is neither transferable nor convertible to cash and must be accepted as awarded. Any changes, cancellations and/or adjustments, and any associated costs are the sole responsibility of the winner(s).

The chances of being selected as a prizewinner in this Contest ("Prizewinner") depend upon the total number of entries received.
